Our existing commitment towards a 100% transparent, traceable and sustainable palm supply chain by 2020 is currently being reviewed. Our policy is rooted in the Principles and Criteria of the Roundtable on Sustainable Palm Oil (RSPO) and we believe they serve as the primary global sustainability standards for palm products and encourage all end-users of palm oil and palm oil products in the mature markets.

We also promote the use of RSPO certified materials to our existing customers whom are either sourcing conventional materials to move to RSPO certified products. We had conducted awareness building session with customers regarding RSPO certification in bid to help them to be more aware of RSPO.

In Malaysia, we have an on-going program with WildAsia since 2013 to supports the production of CSPO among independent smallholders and subsequent certification. The Cargill refinery in Malaysia continuously source the smallholder CSPO via the certified mill in the supply chain.

In Latam, we have conducted two projects to support SH sustainability improvements, in order to push them closer to RSPO certification.

The first one is aiming at certifying 105 smallholders that are part of Palmas del Ixcv°n supply base. 90% of infrastructure requirements were completed already and first pre-audits were conducted. Due to COVID restrictions, and to push forward the improvements, two field technicians were hired to conduct one on one trainings. Final versions of all studies are in progress and digital tools to support the improvements of the farmers are under implementation. Palmas del Ixcv°n is already RSPO certified and is aiming that the smallholders are certified by January 2022.

Also, to contribute to the transformation of the Colombian palm oil value chain by boosting the adoption of best practices according to the Voluntary Sustainability Standards among smallholder palm oil farmers, in February 2020, a partnership between Cargill, Oleoflores and Solidaridad was established to provide an innovative technical assistance program driven by digital tools. Smallholder palm oil farmers got access to a mobile app which allowed them to do a self- assessment questionnaire to evaluate their challenges (Farming Solution). After that, they had access to tailor made training (Agrolearning) and to a financial inclusive scheme (Agroprestamo). Farming Solution was successfully implemented for the clusters of Oleoflores in Maria La Baja (Bolv#var) and Tibv] (Norte de Santander). It covered 13,570 ha (Total area), 5,964 ha (Palm oil area), including 402 palm oil producers (96 women), all of them smallholders with less than 50 hectares. General performance shows that producers have a compliance of 63% against RSPO and the national law. Business and people pillars are the one with better practices, but still with significant gaps to improve. During the project implementation, 156 palm oil producers were monitored in more detail to demonstrate progress through a second assessment using Farming Solution. The results show that producers in this group have increased their compliance from 58% in the baseline to 66% in February 2021.

The scope of our participation is for both Latam and Indonesia Cargill and 4 others palm companies convened by Forum for the Future, an independent non-profit working with private and public organizations to solve complex sustainability challenges, under the umbrella of the Decent Rural Living Initiative. The initiative seeks to improve the protection of human and labour rights of workers in the agriculture sector, the goal is to empower rural communities by establishing cross-industry and stakeholder partnerships to address worker-centric barriers and going beyond compliance. To lead the process of certification system and standard for independent smallholders through various platforms (standing committee Smallholders, Task Force RISS, Partnership with NGOs and other parties).

We have worked jointly with RSPO LATAM in offering capacity building spaces related to topics included in the standard and in NDPE pillars that remain a challenge for growers in LATAM. For instance, we jointly offered a course about HCSA Implementation in which 66 students of different LATAM mills participated. Also, we have invited RSPO in explaining their perspective in topics such as peat management in the webinars we celebrate through our engagement platform Connected4Change.

We also promote the use of RSPO certified materials to our existing customers whom are either sourcing conventional materials to move to RSPO certified products. We had conducted awareness building session with customers regarding RSPO certification in bid to help them to be more aware of RSPO.
