Feedback from our bankers in client / prospect meetings that Asian regional, Chinese, Taiwanese and Japanese banks are not applying ESG standards to deals in the sector, placing us at a disadvantage. There needs to be more work done across the RSPO membership to reward /recognize the efforts of committed members and to pressure other players to join and support a sustainable palm oil industry. The issuance of green financing (e.g. green bonds / loans, sustainability-linked bonds / loans, etc.) is also affected by some second party opinion providers being unwilling to consider palm oil growers as credible, including RSPO certified ones.
