To encourage our suppliers to embark on the RSPO journey, we have incorporated RSPO requirements in our series of initiatives to engage our suppliers and facilitate their compliance. We have established several initiatives under our Anchor Programmes including Priority Suppliers Engagement Programme (PSEP), which is designed to assess our prioritised suppliers, level of compliance with Apical, Apical's Sustainability Policy and other relevant industry requirements, e.g. RSPO. Due to Covid-19 movement restrictions, we introduced the Collaborative Remote Engagement (CARE) programme in place of PSEP. Our Shared Value Programme comprises a series of workshops that furnishes our suppliers with exclusive market insights and industry best practices. We also underscore the benefits of international certification schemes, e.g. RSPO and update our suppliers on the latest environmental legislation.

Additionally, Apical recognises the challenges independent smallholders faced to increase their productivity and meeting sustainability standards. In 2020, we launched the SMILE programme, where we seek to help independent smallholders to improve their yields and obtain sustainability certification. Through customised seminars and workshops, SMILE will educate farmers on yield improvement, sustainable farm management, NDPE, support smallholders to obtain RSPO certification by 2030 and provide training on robust safety measures. Apart from engaging with our suppliers to encourage RSPO best practices, we are also looking to further drive innovation and transformative change via digitalisation. Additionally, we constantly strive to demonstrate the sustainability of our products by certifying our operations under schemes such as the RSPO in order to promote a more demanding market for certified palm oil and products. Moving forward, we will continue to have more dialogues with our buyers on sustainable products that we are able to produce by committing to sustainable palm oil production.
