We are seeing more of a shift from customers' expectations to source sustainable which will drive this target. Currently, roughly 70% of our global palm oil is CSPO through Mass Balance and Segregated Supply. With a new ESG & Sustainable Performance strategy this will bring RSPO into greater focus.
