Palm oils and palm derived products volumes at Kerfoot are very small and tend to decrease. 2021 volumes are much lower than 2020 due to an important stock of refined palm oil being available end of 2020 that's been sold throughout 2021 (so no new purchase needed). Kerfoot only trades RSPO certified palm products.

At Oleon, the supply and premium on the oils stayed stable and was of no major concern for the BU. However, for the palm derivatives (mainly PKO) the premium increased significantly throughout 2021 which impacted Oleon's business. From the sales point of view, Oleon customers' interest in certified palm stayed at the same level.

We believe that in order to move towards greater sustainability, it is necessary to draw jointly on several schemes. Therefore, Avril equipped itself since 2019 with an internal standard which includes the following requirement: 100% of

supplies each year must be covered by sustainability schemes, by order of priority:

- RSPO Mass Balance (MB) or RSPO Segregated (SG) certificates that comply with requirements of customers concerned;
- ISCC-EU certificates to comply with European union regulations on biofuels;
- Field projects with suppliers or local plantation operators;
- RSPO credits purchased to enable the coverage of all supplies.

The 100% coverage target was met in 2019, in 2020 and in 2021.

#### Others

Avril formalized its Sustainable Palm Policy in 2016, and reviewed it in 2020. Through it, the Group aims to ensure that only zero deforestation palm oil will be used. This policy, drawn up in the context of combined efforts with an NGO, The Earthworm Foundation (EF), applies to all the palm oil purchased by different Group subsidiaries. Moreover, Avril aims at assuring a 100% traceability back to the mills for all its palm oil purchases and contributes to transformation on the field by financially supporting on-the-ground programmes, including EF's APT Programme in Indonesia. Avril has also a partnership agreement with EF where they analyse our mill list for potential risks and support us when we receive a grievance case.
