Palmar de Altamira S.A.S., is located on the sidewalk of Palmarito, municipality of Orocué – Department of Casanare. The activity that the organization develops is highly inclusive and sustainable, seeks the development of oil palm producers in the region, benefiting an approximate production core of 13.900 hectares of which 3.003 hectares correspond to the fruit itself and 10.900 are from suppliers; 35% are from small and medium-sized producers in the Casanare department. The FFB received are processed at the Palmar de Altamira Extractor Plant which has a capacity of 50 Tons/Hour. The approximate production of the own crop is 30 Tons/HA.
