Amorepacific uses about 230 types of palm oil-derived raw materials. The raw materials have sequentially being changed to MB palm oil. However, because some raw materials are difficult to change immediately, it is difficult to use only RSPO-certified sustainable palm oil from physical supply chain options. So, Amorepacific is aiming for a 90% change by 2023.
