Bulk palm oil and bulk palm kernel oil were purchased as segregated or mass balance certified. The small volume of uncertified palm oil (0.04%) is present within unique purchased raw materials (colours, flavours and sprinkle). These raw materials suppliers have been contacted to determine if their palm oil additions can be changed to a certified palm oil source. In the meantime the small volume will be covered by RSPO credits under the 95% rule.
