In 2020 we had about 99% percent RSPO certified palmoil based on the mass of used palm oil and palm kernel oil. The aim to have 100 percent RSPO-certified palm oil is reached. The annual report for year 2021 will be released in June. We also promote this through our sales managers in discussions with our customers.
