Trecate site obtained the certification against RSPO MB Standard in July 2019.

The Subsidiaries with distributor license: Eigenmann & Veronelli Iberica S.L. (Member since July 2021) and Eigenmann & Veronelli KİMYASAL TİCARET VE SANAYİ AŞ (Member since March 2022) distribute products containing palm oil derivatives for industrial use. Considering the Membership dates of subsidiaries, ACOP 2021 doesn't include their amounts.
