Our own manufacturing unit (VLEVICO) (cheese, salads, meatdishes,...) has been certified. We will continue to work with our suppliers that still do not use physical chains to switch to physical RSPO supply chains: SEG for food and MB for non food. Yearly we send out an e mail to all our suppliers that use palmoil as an ingredient (we talk about several hundreds of products) to check if they use RSPO palmoil. We check their auditing proofs and if there is a problem we work with them to switch to RSPO palmoil. We continue to work with our suppliers to decrease the use of certificates. we engage them through conversations and collaboration
