We have made significant progress towards our target and have achieved 94% RSPO-certified sustainable palm. Following further detailed investigations, we are in the process of reviewing the existing Fonterra Standard and discussing with our regional markets the challenges, barriers, and opportunities in moving towards this 100 percent segregated supply target. The non-RSPO volumes relate to our usage of RSPO credits to cover gaps in certified uptake. We only have one remaining manufacturing site which has constraints in using certified palm oil due to scale of demand, and the ability of our manufacturing facilities to provide segregated production lines. In this respect we are continuing to work with our manufacturing provider to develop solutions.

We committed to having an updated standard in place at the end of 2021, however during review we identified the opportunity to embed the process within the business which extended our timeframe. Our internal standard which includes a commitment towards moving to 100 percent segregated sourced palm oil, with timebound action plans for each region will be in place by the end of 2022. In doing this, we are working with each region individually to understand the constraints, barriers and opportunities. This approach provides a more in-depth understanding as to "why" the previous target was not been met and seeks to ensure that any new timebound commitment can be achieved. This is noting that we have made significant progress (and ongoing) since 2018 despite our own "Fonterra" target not having been achieved.
