RSPO registered owners of fatty alcohols feed their material in our feed tanks which is further processed by INEOS. There are 2 types of processing INEOS is involved in:

- Processing the fatty alcohol for sales to our own customer. In this case INEOS owns the fatty alcohol (In 2021 only 1 customer)
- Processing the fatty alcohol on behalf of our own customer (tolling). Customer stays owner of the fatty alcohol and receives the material back. INEOS does not have ownership of the materials in this type of processing (main activity).
