We do not have any plans to use RSPO Credits. Covid 19 has had a negative impact on both the usage and the supply of RSPO products to JDS. The lack of guaranteed availability of RSPO segregated palm products, combined with the enormous premium now demanded by suppliers, has led to a lack of confidence in customers, who are reluctant to switch to RSPO sourced product.
