The John Lewis Partnership's policy is to source 100% RSPO Certified Sustainable Palm Oil from Mass Balance or Segregated supply chain models for all palm-based ingredients across all of its own-brand products (including food and non-food).

Where our policy requirements have not been achieved, we ensure that an equivalent number of RSPO IS-Credits are purchased while we work with suppliers to achieve compliance.

As a member of the Palm Oil Transparency Coalition, we engage and assess the most significant palm oil importers on their ambition, commitments, progress and impact. This assessment includes many questions focused on support for smallholders.

In 2021 we've bought RSPO IS-Credits to cover 100% of our palm oil footprint in animal feed. This supports IS and ensures that all of our palm oil footprint (direct and indirect) is RSPO Certified.

Our 2021 target was 100% physically RSPO Certified palm-based materials in products. In 2021, 25.3% of our footprint was RSPO Mass-Balance certified, 72.1% was certified as RSPO segregated, and 2.6% was RSPO-IS credits due to one supplier being uncertified. In total, 97.4% was RSPO physically certified.

We will continue to work to close this gap to achieve 100% of RSPO physically certified. However, the primary focus of our efforts is on increasing the share of RSPO Segregated materials.

There is negative public opinion of all forms of palm oil including RSPO certified.

We work to help address this as part of the UK Roundtable on Sourcing Sustainable Palm Oil's Communications Working Group. We also communicate about sustainable palm oil on our website and via our communications channels.

Low customer recognition for RSPO trademark and brand.

There is currently no supplying the marketplace for many RSPO SG Derivatives and a lack of market transparency about availability, which makes it hard to source RSPO SG materials in non-food products. We have requested help with this from the RSPO, via the RPOG.

For very low users of palm oil in the supply chain, the audit burden of RSPO Certification is often significant and disproportionate.
