Kemin Cavriago purchases hydrogenated palm oil, stearic acid and stearic acid salts as feed materials to be used in production of feed additives, feed premixtures and complementary feed. Kemin Industries BV purchases palm products for the manufacture of feed additives and flavorings. In North America, approximately 100% of the palm oil that we purchase is certified through MB.
