We purchase 100 % of our Crude Palm Oil from one single supplier, who has implemented since December 2013 a policy of "No Deforestation, no Peat, no Exploitation" (NDPE).  100 % of each shipment is traced back to each mill in the producing countries which have processed the Fresh Fruit Bunches (FFB), with the GPS longitude & latitude, building up each sea shipment. Each of these mills is committed to implement & to respect this NDPE policy, failing which it would be banned.  We are also officially entitled by our supplier to provide this traceability to our final customers, who are the french feed
manufacturers
