Imbalanced supply-demand equation of Certified PKO products - the demand is increasing steadily over the years but the supply is limited. This has resulted in the premium of MB CPKO rising up to a record of \$150/mt premium. We urge RSPO to urgently look into ways to overcome the supply crunch of certified CPKO.

Ever-changing business environment - The prices of palm oil is at all-time high which is driving hyper-inflation all over the world. High RSPO premium may affect affordability and buyer's interest which may lead to lower sales/ demand in the year 2022.

Certification standard for Smallholders - To lower smallholder's P&C certification requirement so as to enable more smallholders to participate in the certification process.
