Oxiten S.A. buys refined PKO for its site in Brazil named 'Oleoquímica', where Oxiten S.A. splits it into fatty acids and glycerin and transforms part of the fatty acids into fatty alcohols. These three PKO derivatives are supplied to customers in the market but also can go to other sites in Brazil, Uruguay, Mexico and United States belonging to Oxiten S.A., where Oxiten S.A. processes them into other finished products such as alkoxyated, fatty alcohol, alkoxyated fatty acids, among other. Additionally, Oxiten S.A. also buys fatty alcohols and fatty acids for its sites in Brazil, Uruguay, Mexico and United States.

The PKO certification (which represents 10% of the entire plantation) depends on the PO certification. The premium on the sale of certified PO does not pay for its certification process, so, there is no interest by suppliers in have their plantations certified.
