Perrigo maintains 12-13 global manufacturing plants. While it is possible unidentified palm derivative use may occur in some of these facilities, it is likely very minor and we are actively working to capture global usage accurately.

First goal of 100% CSPO for palm oil purchased directly by Perrigo has been achieved. We implemented a policy to exclusively source CSPO and started purchasing MB exclusively in 2015/2016, and received site certifications in 2018. This represents significant majority of Palm Oil use, primarily affecting our infant formula products.

The 2025 goal is to address remaining indirect usage through physical certification (where feasible/appropriate) and RSPO credits. This indirect usage is predominantly CPO derivatives. We are on track to meet this goal.
