We do not own nor manage any certified and non certified entities. Pasternak is a trader without storage facilities. We liase with all parties involved along the supply chain, from grower, mill, buyers, and /or commercial entity, including ocean transportation, and customs; the latter should the need arise.

Pasternak brokers and purchases palm oil and its derivatives from growers/suppliers in palm growing regions. The sales of these purchases are done back to back to refiners or biodiesel producers where demand calls.

The pandemic continued to halt the work force worldwide, thus decreasing the collecting and producing palm oil. Central America continued to face shortages due to climatic changes. It also did not fully recover from the 2020 back to back hurricanes.

The ISCC demand during 2021 was still quite strong, and many suppliers relied on this certification to market their palm oil production. Supply chain participants certified on both RSPO and ISCC schemes can choose to market their oil based on market demand, directly driving the outcome of certified palm oil business.
