Presco already successfully pass through its certification audit (in the same time as SNL) however Presco had not yet achieved its RnCP process (for one among the four estates managed) and therefore certificate was not delivered. The new certification audits for Presco were scheduled in June 2020 then postponed in December 2020 due to the pandemic situation.

The last certification audit occurred in Q3-2021, Presco will close all NCs by end of 2022 and get its certificate early in 2023.
