- partnering with Chester Zoo to fund the Kinabatangan Orangutan Conservation Programme in Borneo, Indonesia which helps protect critically endangered Bornean orangutans. Chester Zoo works with a number of leading organisations, including RSPO, to transform the palm oil industry into one that is fully sustainable. They undertake valuable conservation work in south-east Asia to protect species threatened by extinction. Our partnership also enables us to raise awareness of the benefits of using sustainable palm oil with employees, retail customers and consumers.
