For some of these materials, there is no RSPO option available - and for some, it is available, but without a demand in the market due to either the pricing of the RSPO option, or the fact that an RSPO claim is not made on the finished product labelling.

Where at all possible, we have started to source only the RSPO material.

The reason for the relatively low % of RSPO sourced material is indicative of the bigger volume products sourced (i.e. Glycerine & Stearic acid), where Mass Balance is available, but not currently in demand.
