Our 2021 palm reporting captures a slight decrease in RSPO credits needed in comparison to 2020. However, we are still working to improve our collaboration on palm oil purchases to address any proposed increases. In addition, we will work to transition products from Book & Claim to physical supply chain (MB/SEG/IP), where physical supply chain sources are available in order to meet our target of 100% RSPO certified palm oil by 2024.
