Additionally, we will continue to monitor our supply chain partners to ensure that our policies and procedures ensure our suppliers' operations are consistent with our commitment to sustainable palm oil which include: Thoroughly communicating our sustainable palm oil principles with our direct suppliers; Meeting the principles for protecting forests, peat lands, and human and community rights; and complying with all RSPO Principles and Criteria; Participating as members of the RSPO and requiring that 100% of our direct palm oil purchases come from suppliers who participate with the RSPO; Requiring through our Global Supplier Code of Conduct, that our suppliers commit to ethical business practices, respect for human rights, and reduce the impact on the environment; Annually reporting updates on achieving our commitments as part of our Corporate Impact Report; Contributing and participating in customer palm oil questionnaires related to sustainability. _____
