Demand and world market is still in the progress of recovery from the effects brought by pandemic (Covid-19) to the world market that caused long damaged to global production and supply chains. First and third world countries are in varying stages in coping with the effects of the pandemic (lockdowns and slow on demand /supply) and its fall out. Many business have to close out or applied for bankruptcy. Although world market is up 16% near-term growth in their economies compared to 2020, overall economic optimism continue to decline and new threat looms (Russia and Ukraine conflict). Bulk of oil palm products (Palm Oil and its derivatives) sourced and purchased remained conventional (89.72%), while certified palm oil and palm olein both MB is at 10.3%
