Clear targets will be defined in 2022. We target a 100 % share for raw materials with high volume (>10 tons) and used in critical industries. At this point of time, we do not see a fully 100 % share due to the high number of different products we are using: - partly with very small content of palm (kernel) oil - partly in very small volumes - partly not available in certified quality.  The palm (kernel) oil depending raw materials are processed in several thousand WACKER products which are specified for years and where we have limitations to make changes in the composition.
