We are a manufacturer of alkyl polyglycoside products. What is needed is a fatty alcohol product made from palm kernel oil. The main purchased fatty alcohols are C8-C10 fatty alcohols and C12-C14 fatty alcohols. There are also C16-C18 fatty alcohols, which are eventually processed into finished products. Among them, the demand for C8-C10 fatty alcohols is higher.

The prices of fatty alcohols made from RSPO-certified palm kernel oil are higher than ordinary fatty alcohols, and the market pricing of some of our products is low. If all of our products become RSPO-certified products, our market competitiveness will be weakened, and our audience and customer base will be reduced.

At present, the delivery cycle of purchasing RSPO fatty alcohol is long(two or three month), and the price of RSPOcertified fatty alcohol is higher than that of ordinary fatty alcohol. Some of our customers cannot accept such a high price, so it is impossible to achieve the goal of purchasing only RSPO-certified fatty alcohol.

Some countries are still concerned that the price of the product is higher than the quality of the product. Their principle is to apply, not to keep improving, so most of the product distribution and market demand are in the hands of customers .
