We have used RSPO credits to cover 151 tons of palm oil and 453 tons of palm kernel oil, in total 604 tons for food. This is equivalent to about 1,42 % of our total use of palm oil products in Arla Foods Amba. It remains to be a challenge to find segregated certified palm oil products in the Middle East.

We have also used 75000 tons of RSPO palm oil and 12000 tons of palm kernel expeller credits for palm used in animal feed. This normally are/should be covered by feed companies. It is even a bigger challenge to find segregated certified ingredients for animal feed.

It is the first time we register RSPO credits bought to cover palm use in the animal feed.
