While mass balance is available and being purchased in North America, the infrastructure is not yet set up for true Segregated Supply. Aspire Bakeries continues to work with customers and encourage our industry to move towards sustainable, traceable options in sourcing palm oil. If and when additional Aspire Bakeries customers outline expectations around using CSPO, we will continue to make necessary investments and provide solutions to meet their ingredient standards in those markets which are not yet using 100% CSPO.
