The remaining 1.9% consists of a combination of credits to support the production of sustainable palm oil and the fact that the final manufacturer is not supply chain certified themselves and so, even though the palm oil comes from a sustainable source, the chain of custody cannot be passed on. Bidfood is working hard with manufacturers to obtain the supply chain certification.
