Compared to previous years, the changes in prices of animal based fats on the one, and palm oil based raw materials on the other hand, have led to a shift of the market demand in favour of plant-based oleochemicals. However, the business environment has become extremely price-sensitive, which has affected our customers' purchase behaviour negatively concerning the sustainability approach.
