Baker & Baker is committed to achieving 100% certified palm oil throughout its entire portfolio although we recognise that challenges still exist for a small percentage of our raw materials, particularly for ingredients where derivatives and fractions of palm oil are used, and the source or credentials of these fractions are difficult to verify.

Baker & Baker is working closely with its key suppliers to gain greater understanding and visibility of the challenges that exist, and how the business will be able to convert the remainder of its palm oil usage to fully certifiable sources.
