The Company operates e-commerce websites in the U.S., Canada, Mexico, U.K., Korea, Taiwan, Japan, and Australia. Our common stock trades on the NASDAQ Global Select Market, under the symbol "COST."

In CY22, more than 99.2% of Costco's tonnage was from physical supply chain options. Challenges for the remaining 0.8% include: new countries of operations with new suppliers who are transitioning and access to derivatives and fractions for regulated items.
