Since 2021, Davis has begun to import SG certified product (historically only MB was handled). For locally sourced product containing Palm Oil, we will continue to support suppliers that use RSPO certified palm oil products. We will continue to provide training to our sales staff to promote our products that are RSPO certified.
