In 2022 we had about 99% percent RSPO certified palmoil based on the mass of used palm oil and palm kernel oil. The aim to have 100 percent RSPO-certified palm oil is reached. We communicate our engagement and commitment to RSPO and CSPO internally and to our Stakeholders (Combined annual Report and sustainability Report 2021, DMK-Website). The annual report for year 2022 will be released in June. We also promote this through our sales managers in discussions with our customers.
