During 2022 we reset our commitments under a revised palm standard including the ambition to hold segregated supply certification for the palm products we purchase. We continue to discuss transition plans with our regional markets addressing the challenges, barriers, and opportunities in moving towards this 100 percent segregated supply target. The non-RSPO volumes relate to our usage of RSPO credits to cover gaps in certified uptake.

During 2022 we updated our Palm Product Standard. This enabled us to recommit to our plan of driving towards 100% RSPO-certified segregated palm as a minimum requirement.

To achieve this we are continuing to identify and investigate any situations where supply is not meeting the new standard. Exemption to the standard requires approval by our palm governance group and must include a transition plan. Imbedding knowledge is being achieved through training sessions with relevant teams (e.g. Procurement), ensuring the actions necessary to meet our Palm Product Standard are understood. We are also introducing supply chain audits to provide assurance of outcomes.
