In our plant we produce solid soap bars and we pack liquid cosmetics mixed by third part companies on formulas developed by GFL. Until 2021 we managed certified palm oil/kernel oil only on soap bars and the data on our ACOP were only limited to the palm oil/kernel oil contained in our soap bars. In 2022 we started managing certified palm oil/kernel oil also in our liquid formulas: the numbers showed in the current ACOP take into account also the derivatives and fractions used in our liquid formulas (shampoo, body wash, liquid soap, conditioner, body lotion).
