As a member of the German forum for sustainable palm oil we are obliged to use only segregated palm kernel oil for the markets in Germany, Austria & Switzerland. For using 66t Mass Balance palm kernel oil we bought small holder certificates. Also for 3.2 tons of mass Balance fractions we bought the corresponding amount of 4 IS palm certificates.
