And there are some suppliers who use RSPO Palm but are not certified themselves. This is because some manufacturers/suppliers would rather go in the direction of being palm-free because of the reputation that palm fats still have despite sustainable certification. And if they no longer process raw materials containing palm (or only very small amounts), they want to do without the certification and the associated effort.
