We have continued to experience market difficulties over the past 12 months in our supply chain resource for palm kernel oil and as such we have been unable to return to using SG certified palm oil as supply is unreliable or unobtainable. We have increased our stock holdings to allow for increased shipping delays.
As the market remains tight for supply of any form of certified palm oil for the foreseeable future - our business will continue to operate a supply chain model with MB only.
