We have succeeded in securing increased quantities of certified products, and are maintaining higher stocks so we are always in a position to supply certified material. Part of the increase in uptake of certified products is due to our higher inventory levels.

It remains a challenge to convince customers to pay more for certified material, but by having ready stocks we at least mitigate the issues around availabilities and lead times.
