There are some 1,200 K-food stores in Finland, with 1.2 million daily customer visits. The K-food store chains are K-Citymarket, K-Supermarket, K-Market and Neste K service stations. Over 600 K Group grocery stores offer online services.

If for some reason, the private label supplier is unable to provide sufficient verified information on use of CSPO, Kesko obtained the RSPO credits itself. 2022 this was under 5%.
