Usage/consumption of type of palm oil (certified x non-certified) is dependent strictly on our customers (retail chains). Certified palm oil is more expensive. It is up to them which type of oil they would like to use. Based on their wish, we purchase appropriate margarine (either produced from certified or noncertified palm-oil). However, we can add that there has been a huge shift in requirement from non-certified level margarine to MB level margarine in 2022. Currently in vast majority of products marketed under retail-chain brand we already use MB level margarine only.
