- 1.) Imbalanced supply-demand equation of Certified PKO products - the demand is increasing steadily over the years, but the supply is limited. The premium of RSPO-certified CPKO is too high. We urge RSPO to urgently look into ways to overcome the supply crunch of certified CPKO.
- 2.) Regulatory changes in certain regions/ countries that drives the demand consumption.
- 3.) High RSPO premium may affect affordability and buyer's interest which may lead to lower sales/ demand in the year 2022.
- 4.) Certification standard for Smallholders - To lower smallholder's P&C certification requirement so as to enable more smallholders to participate in the certification process.
