Others

During product development, we increasingly see only ingredients available with Palm without certification or only MB certification. With new suppliers we see that they do not comply with the RSPO regulations. No mention of RSPO name or certificate number on specification, receipt or invoice. We see wholesalers and custumers who supply or purchase RSPO ingredients without being an RSPO member themselves and without knowing that there are regulations concerning RSPO. As a customer or deliverer, we have to educate them in this matter in order to prevent deviations at the RSPO audit.

We also see the social development 'Palm Free' food products. RSPO is not seen by consumers as a reliable certification. In addition, they see palm as unhealthy compared to alternative fats. Where possible, the urly users choose palm-free products.
