Oxiteno buys refined PKO for its site in Brazil named 'Oleoquimica', where Oxiteno splits it into fatty acids and glycerin and transforms part of the fatty acids into fatty alcohols. These three PKO derivatives are supplied to customers in the market but also can go to other sites in Brazil, Uruguay, Mexico and United States belonging to Oxiteno, where Oxiteno processes them into other finished products such as alkoxylated, fatty alcohol, alkoxylated fatty acids, among other. Additionally, Oxiteno also buys fatty alcohols and fatty acids for its sites in Brazil, Uruguay, Mexico and United States. Oxiteno also has a certified distribution center in Brazil and a certified commercial office in Belgium.

Oxiteno was merged with the Indorama Ventures company in April 2022 and is adapting itself to ensure one voice between the companies on the RSPO topic. Moreover, with the merger, there are 15 RSPO certified sites with the possibility of selling products from certified chains.

There is the desire and the work to increase the percentage of products purchased certified, however the availability in the market does not reflect the demand. Therefore, it has been studied the realization of projects with small holders to develop them in agro-ecological practices that are in line with the RSPO requirements.
