Premier Foods and our palm oil suppliers are all members of the Roundtable on Sustainable Palm Oil (RSPO). We continue to require that our suppliers follow the development, and implementation, of the RSPO guidelines to ensure that we are at the forefront of sourcing sustainable third party certified palm oil. During 2022/23 we are increasing the volume of segregated palm oil we are using. UK Sustainable Palm Oil Initiative Premier Foods is working with Efeca an organisation that runs the UK Sustainable Palm Oil Initiative, an industry-led UK Roundtable on Sourcing Palm Oil under the Partnerships for Forests programme. Efeca works with members to develop the goal and scope of the sustainable palm oil initiative, Efeca provides technical assistance to support member decision-making. This includes providing technical support to both private and public sector actors including training and awareness raising (including of Government Buying Standards); facilitation of a communications working group, aiming to improve the narrative of sustainable palm oil. We will attend UK/European stakeholder meetings if possible, representing the UK manufacturing sector. We will contribute our experiences to assist colleagues elsewhere in the supply chain fully sustainable palm oil. We will continue to certify our production sites to the RSPO chain of custody accreditation.
