Pure refined and unrefined palm kernel oil: Purchase 100 per cent at least at mass balance from 1 January 2016. Purchase 100 per cent segregated from 1 January 2018. Fractions and derivatives (irrespective of whether palm oil or palm kernel oil based): Purchase 100 per cent at least mass balance since 2020.

For the remaining shares of fractions and derivatives, which are not covered by the supply chain option mass balancing, book & claim certificates will still have to be purchased by the store brand suppliers. In this stance, the supply chain option book & claim should only

be considered a transitional solution. The certificates still required should be purchased from selected, responsible palm oil producers in the context of so-called off-market deals, if possible.
